Please provide     detailed description of the project      evidence of the need for your project      and show who will benefit from it	We provide free, confidential and impartial advice to help people find a way forward, whoever they are and whatever problem they face. In Malton we deliver our advice service by telephone, email and in person from our office on Norton Road as well as weekly drop-in sessions at Ryedale House. We also use our Advice Van to visit rural and community-based locations. We have a free Adviceline for all enquiries open 9 - 4.30 every week day in addition to a Single Point of Contact for people with fuel-related debt or winter-related health issues. Across all our services, we provide people with information, advice, and support on a range of issues including consumer rights, debt, discrimination, employment, form-filling, housing, immigration, legal, money and budgeting, relationships, and welfare benefits.  In December 2022 we became a Law Centre, which will enable us to apply for funding for our specialist services, including legal aid contracts. Without a strong core service, delivered locally and by well-supported volunteers, this would not have been possible to achieve.  The people we support are often the most vulnerable in our community. They are five times more likely to be on a low income and they are often in crisis by the time they come to us which has an impact on their health and wellbeing. 55% of the people we helped in 2022-23 reported having a long-term health condition or a disability. Our advice team comprises around 50% paid staff and 50% volunteers. Specific data on the people we have helped in Malton over the last year is attached with this application.	

	We are requesting support to help us deliver our core service in our Malton town office.
	In particular we are seeking funding towards the cost of an Advice Session Supervisor, enabling us to ensure our service is accessible to Malton residents between 9.00am and 4.30pm Monday to Friday and in particular that our face to face service is accessible through regular drop-in sessions twice a week.
	It costs us £31,442.52 (including on-costs) for our Advice Session Supervisor. £6,000 would contribute an amount that would guarantee our open-door sessions in our Malton office were supervised for the coming year, ensuring that our team of project staff and volunteers are adequately supported in the delivery of our frontline face to face advice service.
	Our open-door advice sessions and face to face appointments are vital for people in Malton who would otherwise be unable to access advice, either due to difficulties using the telephone or digital channels that we run through the whole week. Our volunteers require support and supervision in order to deliver consistent high quality advice and this contribution towards the cost of a supervisor will enable us to ensure that our service is accessible for the most vulnerable people in the community as the cost of living crisis grips.
